



## "SPIRIT of Giving - 2017" Official Contest Rules

**Contest Name:** "SPIRIT of Giving" (herein defined as the "Contest")

**Station:** KCMS/SPIRIT 105.3 FM (herein defined as the "station")

**Station Address:** 19303 Fremont Avenue North, Seattle, WA 98133

### A. Description of Contest:

- The "SPIRIT of GIVING" is an ongoing contest that occurs on SPIRIT 105.3 from Saturday, August 5, 2017 through Friday, September 22, 2017. Station reserves the right to extend contest period at its discretion.
- To participate in the Contest, Entrants must register for the contest online at [www.spirit1053.com](http://www.spirit1053.com) or through SPIRIT 105.3's facebook page at [www.facebook.com/spirit1053.com](http://www.facebook.com/spirit1053.com). All entries must be received by Thursday, September 21, 2017 at 11:59pm (PST). Entries are limited to one per unique valid email address.

### B. How Contest is played:

- Starting Saturday, August 5, 2017, listeners will be directed to enter the SPIRIT of Giving. On Monday, August 14, 2017, listeners will be encouraged to tune in weekdays at 7:25am and 4:25pm (PST) to hear the names of registered Entrants called out over the radio. Names of Entrants will be randomly selected from all valid entries submitted into the contest. **The Entrant whose name is announced will have fifteen (15) minutes to call 1-877-275-1053 to claim the qualifying prize. If the call is not made within fifteen (15) minutes of being broadcasted on-air, the qualifying prize will be forfeited and will not be awarded.**
- Entrants are also encouraged to refer their family and friends to enter the Contest. After Entrants register, a bounce back email will be sent to their email prompting them to submit names of friends or family to refer to the Contest. This is optional to participate and will not impact the registrants entry. All qualifiers are selected at random.
- Once a listener has called back within fifteen minutes, they will receive \$500 for themselves and \$500 to be awarded to an individual, charity or organization. The individual must not be an immediate family member as described by Washington State Law and the individual must not reside in the same household. The charity to be eligible must be a legal non-profit entity in the State of Washington. The station has the right to refuse to award a prize to the recipient if the awarded charity does not fit Washington State's standards. The SPIRIT of GIVING winner must name the gift recipient within one weeks after winning the prize.
- Important Note: By entering the Contest, Entrant agrees that any entry submitted to the Station is the sole property of SPIRIT 105.3, and may be aired in whole or in excerpt by the Station. Entries submitted to the station will not be returned.

- **All prize winners, including individuals selected for prize by a winning listener, must accept the Official Contest Rules and meet the contest eligibility requirements set forth herein.**

**QUALIFYING PRIZE WINNERS WILL RECEIVE:**

- \$500.00 for entrant
- \$500 for individual, charity or organization of choice

TOTAL: \$1,000.00

**Prizes Limitations:**

- Winning Entrants must execute and return any required Release of Liability Prize Acceptance Form within thirty (30) days of notification attempt prior to acceptance and receipt of any prize awarded by the Station. Winners failing to meet this condition will forfeit their prize and an alternate winner will not be chosen.
- Winning Entrants must provide an individual, charity or organization to receive the \$500 prize within 48 business hours of winning.
- Prizes cannot be redeemed for currency or other merchandise and are not transferable without approval from the Station.
- The Station reserves the right to substitute prizes with other prizes of approximately equivalent value.
- Prizes will be mailed to Contest winners unless otherwise decided upon by SPIRIT 105.3. The Station is not responsible for loss or damage of prize when mailed.
- Winners are responsible for all federal, state and local taxes; as well as all duties and fees, if applicable. Any U.S. winner with over \$600 in cumulative prizes within a calendar year will receive an IRS form 1099 and a copy of such form will be filed with the IRS.

**Release and Waiver of Liability:**

- By participating in the Contest, the winner(s) agree to have their name, voice and/or likeness used in any advertising or broadcasting material relating to the Contest without additional financial or other compensation, and may be required to sign a publicity release confirming such consent prior to acceptance of the prize.
- By participating, each Contest Entrant waives any and all claims of liability against SPIRIT 105.3, CRISTA Media, CRISTA Ministries, its officers, directors, employees, agents and Contest sponsors for any damage or personal injury or loss which may occur from participation in the Contest or from the use of prizes awarded by the Station.

**Odds of winning the SPIRIT of GIVING promotion will depend on the number of entries received for the contest.**

**THE FOLLOWING GENERAL RULES APPLY TO ALL CRISTA MEDIA CONTESTS:**

A. Contestant must complete an official entry form and deposit it in the provided entry box. Only one entry per person may be submitted for each contest. Winning entry(s) will be drawn from all valid entries received. If an entry is deemed illegible or does not supply all the information necessary to declare a winner, the entry will be deemed invalid and another entry will be selected. B. SPIRIT 105.3 may require listeners to join THE SPIRIT FAMILY on the station website, [www.spirit1053.com](http://www.spirit1053.com) in order to participate in certain contests. Entry instruction is posted on station website.

C. Station is not responsible for entries not received due to delay of mail service, Internet service outage, computer difficulty or other technical issues.

## 2. Eligibility Restrictions:

A. Contests are open to SPIRIT 105.3 listeners who are 18 years of age or older and who legally reside in the State of Washington.

B. Limit to one entry per person.

C. Only one winner per household is allowed.

D. Persons who are ineligible to win prizes or participate in contests include: (a) CRISTA employees and their parents, spouses, children, siblings and roommates, (b) employees of advertising agencies that conduct business with CRISTA Broadcasting; (c) employees of participating sponsors and promotional partners, and (d) persons employed by radio stations within the Seattle metropolitan area.

3. Contest participants agree that SPIRIT 105.3, CRISTA Broadcasting and contest sponsors have the right to use the name, voice or likeness of contest participants and winners for promotional and advertising purposes without compensation.

4. SPIRIT 105.3 will not disclose or sell participant personal information to parties that are not affiliated with SPIRIT 105.3 and or CRISTA Broadcasting.

5. No purchase is necessary. Purchase does not increase odds of winning.

6. Chance of winning depends on the number of correct and eligible contest participants and entries.

7. Prize amounts and value will vary from contest to contest. Prizes cannot be redeemed for cash or other merchandise. Prizes are non transferable without approval from SPIRIT105.3.

8. Prizes will be mailed to contest winners unless otherwise decided upon by SPIRIT 105.3. Station is not responsible for loss or damage of prize when mailed.

9. Winners are responsible for federal, state and local taxes and fees if applicable. Any person winning over \$600 in cumulative prizes within a calendar year will receive an IRS form 1099 and a copy of such form will be filed with the IRS.

10. SPIRIT 105.3 reserves the right to require contest winners to sign a liability release prior to acceptance and receiving of any prize awarded by station.

11. By participating, each contest participant waives any and all claims of liability against SPIRIT 105.3, CRISTA Broadcasting, CRISTA Ministries, its officers, directors, employees, agents, and contest sponsors for any damage or personal injury or loss which may occur from participation in the contest or from the use of prizes awarded by SPIRIT 105.3.

12. Contestants are required to provide truthful information. SPIRIT 105.3 will reject any entry that the station discovers to be false.

13. SPIRIT 105.3 reserves the right to disqualify any participant attempting to tamper with the contest entry process.

14. SPIRIT 105.3 reserves the right to substitute contest prizes with other prizes of approximately equivalent value.

15. SPIRIT 105.3 reserves the right to cancel or modify contest and contest rules at any time.

By entering, Entrants acknowledge they have read, understood, accepted and agreed to be bound by the terms and conditions of these Official Contest Rules, as they may be amended from time to time.

Entrants may not sell, assign or transfer any of their rights under these Official Contest Rules or as may be granted throughout this Promotion. Entries that do not comply with all requirements stated in these Rules will not be considered and will be disqualified.
