Description of Contest:

A. Dates of the Contest

- The "Vacation to Disneyland® Resort" Contest will begin at approximately 12:01am Pacific Standard Time (PST) on Saturday, April 21, 2018 and ends at approximately 11:59pm (PST) on Friday, May 4, 2018 (herein defined as "Contest Period"). To participate in the Contest, the Station requires Entrants to be a member or become a member of "The SPIRIT Family." Directions for membership are located on the Station website at www.spirit1053.com. **All entries must be received by Friday, May 4, 2018 at 11:59pm (PST) for consideration.**

B. How to Enter the Contest

- On-Air Entry:
 - Each weekday during the Contest Periods (7am and 10am hours) SPIRIT DJ's will give the cue to call. At this time, listeners will need to be the correct caller to pick up a qualifying Disney gift card. Plus, the chance to win a Vacation for 4 to Disneyland Resort® to experience the Season of the Force.
 - One winner will be randomly selected from all qualifiers during the contest period on Monday, May 7, 2018.
- Online Entry:
 - Listeners will have a second chance to win the vacation online at www.spirit1053.com. In order to enter, you must become a member of the SPIRIT Family. One winner will be randomly selected from the online entrants on Monday, May 7, 2018.
