



## KWPZ - FM Recruiting Practices

KWPZ - FM, a station of CRISTA Media, is wholly owned by CRISTA Ministries, a Christian not-for-profit organization. As such, we are selective in our hiring practices, hiring only those who are of the Christian faith and who agree with the CRISTA Ministries "Statement of Faith." This statement is included as part of CRISTA's employment application. Applicants must indicate that they have read and agree with this Statement of Faith and that their personal beliefs are in conformance with it.

In recruiting potential hires of like faith, the stations of CRISTA Media utilize the following recruitment practices:

1. CRISTA Human Resources lists all current openings on the CRISTA web site ([www.crista.org](http://www.crista.org)) along with an abbreviated job description and online application. 2. When appropriate, we advertise job openings with Job Banks such as Washington State Association of Broadcasters (WSAB) as well as on local job sites such as *Craigslist*. 3. Throughout the year, CRISTA Media is represented at career and job fairs.
4. When appropriate, we utilize our own airwaves to advertise openings, as this represents the best way to reach a large body of diverse men and women who tend to share a common faith.
5. CRISTA Media stations practice ongoing interviewing and recruiting for account executives (sales) positions.
6. CRISTA Media stations provide internship programs. CRISTA stations have ongoing direct contact with local colleges and have employed interns from schools including Seattle Pacific University, Northwest University, Western Washington University, local community colleges, the University of Washington, and other institutions.
