CASHTOBER GIVEAWAY
OFFICIAL CONTEST RULES**

1. How to Enter the Contest:

- a. The KFAT CASHTOBER Giveaway will begin on **Monday, October 2nd, 2017** and end on **Tuesday October 31st, 2017**.
- b. The KFAT Cashtober sounder will be played at random on weekdays (Monday through Friday) 6am through 7pm.
- c. Call times will be amended for holidays. In this event, KFAT-FM will announce on-air the next call time and date. KFAT-FM also reserves the right to amend any call time for any reason, and will announce on-air the next gameplay time and date.
- d. At appointed call times, the 9th caller at (907) 341-5328 will win a check for one hundred dollars.
- e. Persons are allowed to win once. Only one winner allowed per household.

2. Eligibility Restrictions:

- a. The contest is open to all KFAT listeners who are 18 years of age or older and legal residents of the state of Alaska (must provide proof of ID) and reside within the KFAT Alaska broadcast area. Military entrants with out of state IDs must establish proof of residence in the state of Alaska to be considered. Employees of Ohana Media Group, LLC, affiliated advertising agencies, participating sponsors/promotional partners, other radio stations in the Anchorage metropolitan area and the members of their immediate households are ineligible to participate or win.
- b. Any person who provides false information regarding identity or any other required information will be automatically disqualified from the contest and will become ineligible to participate in ANY future contests hosted/held by Ohana Media Group and any of its six stations.
- c. Listeners cannot enter this contest under anything other than their full legal name, as verifiable by their valid state ID. Providing another name or alias will result in immediate disqualification and will yield the listener ineligible to participate in the contest.
- d. Listeners are eligible to win a KFAT contest only once every 30 days. Only one winner per household is permitted in any contest.

3. Prizes:

a. The prize is one check for one hundred dollars.

b. All checks may be picked up at the office of KFAT, 833 Gambell Street, Anchorage, AK 99501, Monday through Friday during the normal business hours of 8:00AM and 5:00PM. Any prize or prize certificate not claimed within thirty (30) days of winning will be forfeited by the winner. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its arrival. KFAT is not responsible for the safe arrival of a prize or prize certificate. You will be notified when check is ready for pickup.

c. Contest prizes are not transferable. Prizes may not be substituted for or redeemed for cash.

4. Selection of Winners:

a. Decisions of station management with respect to the contest are binding and final.

b. Only one winner per household.

5. Telephone and Delivery Disclaimer:

a. Participants are restricted to the use of ordinary telephone equipment.

b. Participants that enable the "Caller ID" block function will not be allowed to participate unless they enter their correct area code and telephone number if prompted, or disable the features inhibiting their participation in the Contest.

c. Participants using equipment not set up for toll free phone exchanges (800, 888, 877, 866, etc.) may experience call connection problems.

d. KFAT disclaims all liability for the inability of a participant to complete or continue a telephone call due to equipment malfunction, busy lines, inadvertent disconnections, acts beyond KFAT's control, or otherwise.

e. For all contests KFAT disclaims all liability for any delays, misdelivery, loss, or failure in the delivery of any item sent by mail, courier, express, electronic transmission, or other delivery method.

f. KFAT is not responsible for mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind,

including: failed, incomplete, garbled or delayed transmission of online entries, traffic congestion on telephone lines, the Internet or at any website or lost or unavailable network connections which may limit an online entrant's ability to participate in the contest, and any injury or damage to entrant's or any other person's computer related to or resulting from participating in or downloading any information necessary to participate in the contest.

g. Entry forms in a register-to-win contest must be handwritten. No photocopies or mechanical reproductions of entry forms are permitted.
