**OFFICIAL CONTEST RULES**

1. How to Enter the Contest:

- a. The “AirKFAT Flyaway” contest will begin on November 6<sup>th</sup>, 2017 and end on November 17<sup>th</sup>, 2017.
- b. To participate in the contest, listen to 92.9 KFAT and be the 9<sup>th</sup> caller at the sounder. The 9<sup>th</sup> caller will win an entry into the final drawing to select a winner.
- c. One entry per person.

2. Eligibility Restrictions:

- a. The contest is open to all 92-9 KFAT listeners who are **21** years of age or older and legal residents of the state of Alaska (must provide proof of ID) and reside within the KFAT listening area. Military entrants with out of state IDs must establish proof of residence in the state of Alaska to be considered. Employees of Ohana Media Group, affiliated advertising agencies, participating sponsors/promotional partners, other radio stations in the Anchorage metropolitan area and the members of their immediate households are ineligible to participate or win.
- b. Listeners are eligible to win a 92-9 KFAT contest only once every **30** days. Only one winner per household is permitted in any contest.
- c. Listeners are eligible to win a prize from 92-9 KFAT valued at \$600.00 or more only once every six months.

3. Prizes:

- a. The grand prize consists of two (2) round trip airline tickets from Anchorage to San Jose, California, hotel stay and 2 tickets to Poptopia.
- b. The grand prize winner will be selected from all 9<sup>th</sup> caller qualifiers.
