## XL 103 THOUSAND DOLLAR MINUTE (the 'Contest')

XL 103 THOUSAND DOLLAR MINUTE Rules & Regulations

- 1. CONTEST PERIOD: Launches March 5<sup>th</sup>, 2018
- 2. ELIGIBILITY: The 'Contest' is open to all residents of Alberta, who are 18 years of age or older (age of majority), excluding employees of XL 103, Newcap Inc. ('Newcap'), Newcap's direct and indirect parents, subsidiaries and affiliates, Newcap's advertising and promotional agencies, participating sponsors and any persons residing in their respective households. XL 103 and Newcap Inc. are hereafter collectively referred to as XL 103.

For each correctly answered question, you will be awarded \$10 CDN. If ten questions are answered correctly in the period of one minute, the prize escalates to a total of a \$1,000 CDN.

The following rules apply to the game:

- Only the first response by the contestant to a question will be accepted.
- Contestant may 'pass' on a question and if time remains within the 1-minute period, the host will ask the question again. A contestant may only pass on a question once.
- If the 10th question is being asked while the 1-minute period runs out, the contestant will have an opportunity to answer.
- 4. NO PURCHASE NECESSARY: No purchase is required to enter an XL 103 Contest.
