- 2. The Parent Advisory which was scheduled for Tuesday, December 12 has been pushed back to December 14 at 4:30 p.m. due to the Elementary Winter Fine Arts Festival tomorrow.
- 3. There will be an open house for the CTEC program this Friday, December 15.
- 4. Final Exams will be held on a three day schedule on Tuesday, December 19, Wednesday, December 20, and Thursday, December 21. Students will be released after the morning exams at 11:06, and teachers will complete grading exams that afternoon.
- 5. Our current attendance rate is 94.6%, and we are keeping track of six chronically absent students. We have also placed an emphasis on tardiness, and the results have been positive thanks to the efforts of our staff.

Superintendent's Report December 2017

Building & Grounds:

- <u>Water Bill:</u> As mentioned in your weekly update, the City of Altamont will be adjusting our bill to reflect water usage as a result of us watering the baseball diamond and the sod around the new playground.
- -<u>High School Baseball Field Lights:</u> Mr. Dane Milleville and Mr. Kyle Stuemke will be in attendance at the January Board meeting to provide details on this project.
- -<u>Sound Baffles for HS Gym:</u> We have received the quote from G&S and it exceeds the limit for not bidding. If we would like to move forward with this project, Alan and I will work with them to create bid specifications and the Board will have to authorize for letting of bids.

Technology:

<u>-Next Generation Device:</u> The Team will be setting a meeting to discuss and finalize what our next device will be. Our lease ends in June, so we will need to make decisions on how many of the current devices we want to purchase and how many new devices moving forward.

<u>Polycom Distance Learning:</u> All of the schools and representatives participated in a conference call on November 29th. We planned a face-to-face meeting in December in Champaign. I will be working to have an intergovernmental agreement crafted for the shared course(s). We will also be working with each district's principals and guidance counselors on courses to share and access via the technology. The process is moving along well and will provide more educational opportunities for our students.

Other:

<u>District Emergency Response Team:</u> The team is scheduled to meet on December 5th, I will provide a status update at the meeting.

<u>Hiring Flowchart:</u> Enclosed in your packet are two flowcharts that we use to accept applications, screen and recommend for employment. You will notice that there is one for certified personnel as well as non-certified personnel.

State of Illinois Pilot for Advanced Placement (AP) US History: The State of Illinois Lt. Governor's office is offering a pilot for school districts/high schools to access via Illinois Virtual School the opportunity to take and received credit for AP US History.
