## CKKQ THE Q BC FERRIES VACATIONS OKANAGAN RETREAT CONTEST OFFICIAL RULES & REGULATIONS

(the "Rules")

- 1. The CKKQ The Q BC Ferries Vacations Okanagan Retreat Contest (the "Contest") starts at 6:00 a.m. Pacific Daylight Time ("PDT") on May 12, 2018 and closes on May 27, 2018 at 11:59 p.m. PDT (the "Contest Period"). No purchase necessary. Void where prohibited.
- 2. The Contest sponsors are Jim Pattison Broadcast Group Limited Partnership and British Columbia Ferry Services Inc. (hereinafter referred to as the "Contest Sponsors").
- 3. ELIGIBILITY: To enter and be eligible to win, entrant must be a legal resident of British Columbia, Canada and be nineteen (19) years of age or older. Employees and their spouses, parents, siblings and children, and persons domiciled with an employee of either of the Contest Sponsors, their respective agents, parent, affiliated or related companies, subsidiaries, divisions, prize sponsors, and promotional and advertising agencies and administrators, are ineligible to enter. A winner of a previous British Columbia Ferry Services Inc. ("BC Ferries") or Jim Pattison Broadcast Group Limited Partnership contest within the three (3) months preceding the start of this Contest (including persons designated by such winners to take ownership of prizes) and persons domiciled with a winner are not eligible to enter.
- 4. TO ENTER THE CONTEST, simply visit the website located at <a href="http://www.theq.fm/contests/">http://www.theq.fm/contests/</a>, click on the Contest page and complete and submit your entry by following the instructions found on the Contest page. All entries must include your name, city of residence, postal code, age, ten digit day and evening telephone numbers and e-mail address. Limit of one (1) entry per eligible individual per day. If it is discovered that you attempted to enter more than once per day, all your entries will be void. Entries shall be deemed to be submitted by the authorized account holder of the email address submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an internet access provider, on-line service provider, or other organization (e.g. business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Illegible entries are ineligible. These Rules are the standard terms and conditions applicable to the Contest.

PRIZE: There is one (1) prize available to be won (the "**Prize**"), consisting of two (2) nights' accommodation at the Holiday Inn & Suites in Osoyoos, BC for two (2) people in a Standard 2 Queen or 1 King Room based on double occupancy; One (1) breakfast for two (2) people at Sol Grill Room & Lounge; two (2) nights' accommodation at Coast Capri Hotel in Kelowna, BC for two (2) people in a Premium Room based on double occupancy; and round-trip ferry travel with BC Ferries between Vancouver Island and Metro Vancouver for two (2) people travelling in one (1) standard vehicle. The Prize is based on availability at the time of booking, and is valid through February 28, 2019. The Prize has an approximate retail value of One Thousand Five Hundred Canadian dollars (CDN \$1,500.00). The Prize is based on availability of accommodation and ferry travel at the time of booking for two (2) adults and one (1) standard vehicle. The Prize has no cash value and gratuities are not included. Blackout dates may apply. The Prize winner and his/her travelling companion are solely responsible for all costs not expressly described herein, including, without limitation, as applicable, all transportation (except included ferry transportation), taxes, fuel/currency surcharges, meals (except included breakfast) and beverages, room service, gratuities, merchandise, telephone calls, insurance, any required travel documentation and all personal expenses of any kind or nature. Accommodation and specific Prize elements are subject to availability and change without notice or compensation. It is the sole responsibility of the Prize winner and his/her travelling companion to obtain all necessary travel documentation including passports and visas (if applicable), and to comply with any customs and immigration requirements, as applicable. It is recommended that the Prize winner and his/her travelling companion obtain sufficient personal insurance prior to departure. The Prize may not be used towards any type of reward point accumulation program. No change in travel arrangements can be made by the winner once his/her booking has been confirmed. change without notice or compensation. Any unused portion of the Prize will be forfeited and have no cash value. The Contest Sponsors reserve the right, in their sole discretion, to substitute a Prize of equal or greater value if the Prize (or any portion or component thereof) cannot be awarded for any reason.

DRAW: On or around Monday, May 28, 2018, a random draw for the Prize will take place at Jim Pattison Broadcast Group Limited Partnership, Victoria, British Columbia from among all eligible entries received during the Contest Period. The first entry drawn will be eligible to win the Prize. The odds of winning the Prize will depend on the number of eligible entries received during the Contest Period. Jim Pattison Broadcast Group Limited Partnership, acting reasonably, will attempt to contact the potential Prize winner to notify potential winner that he or she may have won the Prize by telephone within two (2) business days after the draw. In the event that the potential winner cannot be contacted within two (2) business days after the draw, he or she will be disqualified and an alternate potential winner may be drawn at the Contest Sponsors' sole discretion. Proof of identification must be provided upon request.
- In order to be declared the winner, potential winner must first correctly answer, unaided, a time limited mathematical skill testing question administered by Jim Pattison Broadcast Group Limited Partnership. The Contest Sponsors reserve their right in their sole discretion to disqualify any individual they find to be tampering with the entry process or the operation of the Contest or to be acting in violation of the Rules or otherwise in a disruptive manner. In the event of any discrepancy or inconsistency between the terms and conditions of the Rules and disclosures or other statements contained in any Contest related materials, including but not limited to the Contest entry form, or point of sale, television, print or online advertising, the terms and conditions of the Rules shall prevail, govern and control.
