

Official Contest Rules & Regulations  
CKMP-FM | 90.3 AMP RADIO  
**AMP RADIO'S \$500 CASH TRACK (the 'Contest')**

1. **Dates/Terms/Eligibility.** CKMP-FM (90.3 AMP Radio) – Newcap Radio Inc. (the "Station") has set an expiry date of Friday, October 13<sup>th</sup> 2017 for **AMP Radio's "\$500 Cash Track"** (the "Contest"), however it reserves the right to terminate or extend the contest at any time. Any material changes will be broadcast on the Station and posted on its official website ([www.ampcalgary.com](http://www.ampcalgary.com)), within the Contest section. The Contest is open to legal Canadian Residents and students 18 years of age or older, residing in the province of Alberta. There is no purchase necessary to participate or to win. Employees or agents of the Station, all other Newcap Radio stations in Canada, or any entity associated with the Contest, as well as members of the same household of any such employee or agent may not participate.
2. **Cash Prizes.** The individual prizes available to be won are 500 CAD, twice each weekday (excluding statutory holidays). The odds of winning the individual Prize will depend on the number of participants, and attempt to call in to win, and the winning caller will be #29. Individual winners can ONLY WIN one time over the duration of this campaign. There will be a total of 66 winners during the campaign.
3. **Qualifying Prize.** Each individual that wins the cash prize will also instantly qualify to win a 2-year lease on a redesigned 2018 Toyota Camry from Country Hills Toyota. The odds of winning the vehicle will be a 1 in 67 chance, if all qualifiers show up to win. Qualifiers must be at Country Hills Toyota on Thursday, October 19<sup>th</sup> to be into the draw to win. If a qualifier is not able to show up, they may send a proxy in their place, but should the proxy win the vehicle, it is their prize and the original qualifier has no legal action should they try to take possession of the vehicle from the proxy. More on lease info in section 9.
4. **How to Win.** Starting Monday, August 28<sup>th</sup> through Friday, October 13<sup>th</sup> listeners listen to AMP Mornings with Katie & Ed at 6:20am to find out the daily Cash Track and when it will be played. When they hear the Cash Track at that time, then call 403-736-3835, and caller number twenty-nine instantly wins the \$500 CAD prize and the qualifying spot to win the 2-year lease of a 2018 Toyota Camry from Country Hills Toyota.  
**\* All winners of the \$500 Cash Track will be able to pick up their cheque at Country Hills Toyota at the wrap-up party on Thursday, October 19<sup>th</sup>\***
5. **Conditions/Restrictions.** The Winner will be required to produce identification satisfactory to the Station. They will also be required to sign an affidavit of eligibility and release, including a publicity release as prepared by the Station prior to receiving their Prize. The Winner will be responsible for any additional taxes or fees that result from the receipt and/or use of their Prize. The Contest is void where prohibited by law. Anyone using fraudulent means to participate and/or win the Contest will be disqualified. Contestants are only eligible to win if they HAVE NOT won anything with the station in the past 30 days. All winners and qualifiers agree to have Newcap Radio and Country Hills Toyota post their photos or videos on companies website or social media channels with their names.
6. **Conditions/Restrictions.** The Station is not responsible for errors, problems or delays in the mail, telephone or online web systems that may prevent listeners from participating In the Contest. Participants can call the Station main line (403 271 6366) if they have any questions in relation to the Contest. Decisions of the Station judges are final.

- 7. Release and Indemnification.** In exchange for the right to participate in the Contest, each participant agrees to release and indemnify the Station, Newcap Radio and its officers, directors, agents, parent companies, subsidiaries and employees ("Released Parties"), from any and all claims, demands and/or causes of action of any nature or kind whatsoever, whether presently known or unknown, foreseen or unforeseen, that arise out of the participation in the Contest.
- 8. Rules.** This contest is subject to all applicable federal, provincial and municipal laws. By entering, each participant agrees to abide by these rules and regulations and the decisions of the Station judges which are final with respect to all aspects of the contest. Any violation of these rules will result in disqualification. Copies of these rules are available on the Station's website ([www.ampradiocalgary.com](http://www.ampradiocalgary.com)) under the Contest listing, in person at the Station's studios (Suite 100, 1110 Centre Street NE, Calgary, AB, T2E 2R2) during regular business hours (Monday – Friday, 8:30am – 5:00pm), or by sending a request, along with a self addressed stamped envelope, to the Station at this address.
- 9. Lease Prize Information.** A 2-year lease on a 2018 Toyota Camry, white in colour. Prize consists of one payment for the term of two years, 20,000 kilometers per year (40,000 kilometers total) car lease. Winner will be responsible for excess mileage greater than 40,000 kilometers for two years (at cost \$.15 per kilometer), and will assume taxes and vehicle damage responsibility per the lease agreement. If the winner does not meet our contest requirements, the Company reserves the right to determine an alternate winner by conducting a random drawing of the remaining names. Winner must hold a valid Alberta Driver's License and proof of insurance. Prizes are not exchangeable for any other prize or monetary value. Manufacturer's Suggested Retail Price ["MSRP"] 2-year lease value \$20,100. Prize provided by Country Hills Toyota.

Winner is responsible for any expenses associated with the vehicle, including, but not limited to: registration, tax, license fees, insurance, extended warranties and all other costs incurred in claiming, registering or using the vehicle. Winner is also responsible for all costs associated with any optional accessories ordered by the winner. Winner must take delivery and must take possession of the Prize no later than thirty (30) days after receiving notice that the vehicle is ready to be claimed. Failure of the winner to take possession within such time will result in disqualification. Winner must provide evidence of insurance and a valid Alberta driver's license prior to taking delivery of the vehicle. All taxes, upgrades and any other expenses not specifically identified in these Official Rules as included in a prize are the responsibility of the winner.

The Winner may not substitute, exchange, or apply the vehicle's value towards a higher cost or alternate vehicle. Designated vehicle must be the Company designated vehicle that is currently in dealer's stock of inventory. Any costs associated with the delivery of the Prize due to distance or unique circumstances are the responsibility of the Winner.

The vehicle will be installed with a sky patrol for the entire length of the 2-year lease. Any tickets or traffic violations that may occur during the 2-year lease are the responsibility of the Winner. The Winner must insure the Prize with an insurance policy including the following: Third party liability of \$1,000,000, collision deductible of \$1000 and comprehensive deductible of \$1000.

After the two years, the vehicle must be returned to Country Hills Toyota. When returning the vehicle it will be subject to a standard "Lease Conditions Report". Any charges that may occur will be the sole responsibility of the Winner. All service and maintenance must be performed at Country Hills Toyota. All service due on the vehicle for the period of 2 years will be the responsibility of the Winner. Further, should there be any body or collision damage to the vehicle during the 2-year term it must be repaired at Country Hills Collision.
