

"Camila Cabello in Vancouver" CONTEST
RULES AND REGULATIONS

1. How to Enter the Contest

No purchase is necessary to enter. The "Camila Cabello in Vancouver" contest (the "Contest") starts at 6:00 a.m. Mountain Time ("MT") on Thursday, March 29, 2018 and closes on Wednesday, April 4, 2018 at 6:00 p.m. MT (the "Contest Period"). To enter the Contest, listen to 90.3 AMP Radio (the "Station") between 6:00 a.m. and 9:00 p.m. MT for the announcer's cue-to-call the Station's contest line at (403) 736-3835. The random eligible caller to get through on the contest line following the cue-to-call, as determined by the Station in its sole discretion, will be eligible for entry into the Prize Draw (each a "Qualifier"). Each Qualifier will be announced on-air and may be required to chat on-air. If there is not a clear telephone connection between the Station's on-air announcer and a Qualifier, such that one or each other cannot hear the other, such Qualifier will be disqualified, and the Contest Sponsors will not be liable in any way for such failed connection.

2. Eligibility

The Contest is open to legal residents of Alberta who are 18 years of age or older at the time of entry. Employees, officers, and directors (including immediate family members and members of the same household) of Newfoundland Capital Corporation Ltd. and Sony Music Entertainment Canada Inc. (the "Sponsors") and their respective distributors, dealers, marketing representatives, printers, advertising or promotional agencies, or any other organization associated with the Contest are not eligible to participate.

3. Prize

One (1) prize (the "Prize") is to be awarded consisting of:

- roundtrip economy airfare for winner and his/her guest from Calgary, Alberta to Vancouver, British Columbia (departing April 9 and returning April 10, 2018);
- one (1) night's accommodation in Vancouver (based on one room, double-occupancy);
- two (2) tickets to see Camila Cabello in concert on April 9, 2018 in Vancouver; and
- two (2) passes to attend a meet and greet with Camila Cabello on April 9, 2018.

(Approx. retail value of Prize \$1,100.00 CAD).

The Prize winner and guest are solely responsible for all costs not expressly described herein as being included in the Prize. All transportation to and from the departure and arrival airports, other ground transportation except as otherwise specified herein, departure tax, insurance, fuel charges, travel related fees and items of a personal nature, including but not limited to food, beverages, room service, wine and bar charges, gratuities and local and long distance telephone calls, are the sole responsibility of the Prize winner and guest. Prize winner and guest must be able to travel at the times and dates as determined by the Sponsors, in their sole discretion, failing which the Prize will be forfeited. The winner's accompanying guest must be a legal resident of Canada and 18 years of age or older, except that if winner is parent/legal guardian of his/her guest, winner's guest may be under 18 years of age. A valid major credit card must be provided by the Prize winner or guest for hotel check-in and incidentals.

Prize winner and guest must travel together on the same itinerary. No change in travel arrangements can be made by the Prize winner once the booking has been confirmed. Sponsors

reserve the right to change or cancel the booking and to vary itineraries and to substitute hotels in accordance with operating requirements or circumstances beyond their control. Travel and accommodations are subject to availability, blackout periods, government restrictions and regulations, hotel, airline, airport or other transportation restrictions and regulations. Sponsors are not responsible for any other travel arrangements affected due to cancellation, changes or rescheduling of any dates and Sponsors reserve the right not to cover costs related to missed/delayed flights. It is recommended that the Prize winner and guest obtain sufficient personal insurance prior to departure.

Sponsors will not be responsible if weather conditions or other factors beyond the Sponsors' reasonable control prevent the Prize or part of the Prize from being fulfilled. Further, the Sponsors assume no liability or responsibility whatsoever should the Prize winner or guest be denied entry to the airline or concert venue for any reason whatsoever.

Sponsors reserve the right to substitute a Prize in whole or in part for a prize of equal or greater value in the event that any component of a Prize is unavailable for any reason. Prizes must be accepted as awarded and no substitutions, except as identified above, will be made. Prizes may not be sold, transferred or assigned and are not convertible to cash.

4. The Prize Draw

On Thursday, April 5, 2018 between 8:00 a.m. to 10:00 a.m. MT, a random draw for the Prize will take place at the offices of the Station in Calgary, Alberta from among all eligible Qualifiers received during the Contest Period. The first Qualifier drawn will be eligible to win the Prize. The odds of winning depend on the number of eligible entries received. The Station will attempt to notify the selected entrant by telephone within 24 hours following the Prize Draw. In order to be declared a winner, the potential winner must unaided correctly answer a skill-testing mathematical question and, within the time specified by the Sponsors, the potential winner and guest must complete and return the eligibility and liability/publicity release confirming compliance with these rules and regulations, releasing the Sponsors and their respective directors, officers, employees and agents from all liability and, except where prohibited by law, permitting the Sponsors to use their names, addresses (city and province), likenesses, voices, written statements and images, without compensation, worldwide and in perpetuity, in any and all forms of media now known or hereafter devised, including the Internet, in any publicity carried out by the Sponsors. Potential winner and guest must also provide proof of identity (photocopy of Driver's License, Passport or any other government-issued photo identification). In the event that a selected entrant is not eligible for any reason, has not correctly answered the skill-testing question or cannot be contacted after one day of the first attempt to contact the selected entrant, such entrant shall be disqualified and the Sponsors shall have the right to select another entrant and the Sponsors shall be released and discharged from any liability or responsibility in this regard. No correspondence will be made except with the selected entrant(s). All entries submitted become the property of the Sponsors and will not be returned.

5. General

By entering the Contest, entrants agree to abide by these rules and regulations, and further agree that the decisions of the Sponsors are final. Sponsors reserve the right to withdraw, cancel, terminate, amend, modify or suspend the Contest, or to amend these Contest Rules, at any time and in any way, without prior notice, for any reason whatsoever if for any reason in the opinion of the Sponsors, in their sole discretion, the Contest is not capable of operating as planned or if the administration, security, fairness, integrity, or proper conduct of the Contest is corrupted or adversely affected, including by reason of infection by computer virus, bugs, tampering,

unauthorized intervention, fraud, technical failures, or any other causes beyond their control. Sponsors reserve the right in their sole discretion to disqualify any individual they find to be tampering with the operation of the Contest or to be acting in violation of these rules or otherwise in disruptive manner with respect to the Contest. **CAUTION: ANY ATTEMPT BY A CONTESTANT TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSORS RESERVE THE RIGHT TO SEEK DAMAGES FROM ANY SUCH ENTRANT TO THE FULLEST EXTENT PERMITTED BY LAW.** Sponsors also reserve the right to cancel this Contest at any time because of any printing or other error. Sponsors do not assume any responsibility for technical malfunctions, human or technical error, seeding or printing errors, lost, delayed or garbled data or transmissions, omission, interruption, deletion, defect or failures of any telephone or computer line or network, computer equipment, software (including on account of traffic congestion on the Internet or at any Web site) or any combination thereof. Sponsors shall not be liable for any errors or negligence that may arise or occur in connection with the Contest, including any injury or damage to the entrant's or any other person's computer related to or resulting from participation in or downloading of any materials relating to the Contest. Sponsors are not liable for injuries, death, damages or losses of any kind resulting from acceptance or use of the Prize.

6. Privacy and Personal Information

The Station will be collecting data about entrants through the Contest entry. Any personal information will be handled in accordance with the privacy policy of Newfoundland Capital Corporation Ltd. available at <https://www.ncc.ca/privacy/>. By entering the Contest each entrant consents to the collection, use and distribution of his/her personal information (information that identifies an entrant as an individual, such as home telephone number, age and home address) by the Station for the purposes of implementing, administering and fulfilling the Contest. The Station will not sell, share or otherwise disclose personal information of entrants with third parties, other than to third parties engaged by them to fulfill the above purposes or as permitted or required by law..
