For Canadian residents, correct answer to a mathematical skill-testing question is required to win. Chance of winning depends on the number of total number of eligible entries received.

c. How Potential Winners are Selected

At such time, Entrants will need to listen for their name and call the PRAISE Contest Line at 866-729-1065 within 10 minutes to be “qualified” to win the grand prize. Each such entrant who was qualified during the contest period is a “Qualified Entrant.”
- On or around Monday, May 22nd One winner will be randomly selected from all qualifiers during the contest period, and will be announced on air, Monday, May 22nd, 2023 as the Grand Prize Winners
