## **Official Drawing Rules**

## NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

- 1. Eligibility: Participation is open only to individual legal residents of the State of North Dakota who are at least 18 years of age as of the date of entry, and who have a social security number or tax identification number (each an "Eligible Individual"); provided however that employees, officers and directors and their immediate families (parents, children, siblings, and spouse) and members of their household (whether or not related) of the College SAVE Plan (the "co-sponsor" or "College SAVE"), Bob 95 FM, Radio FM Media, Bank of North Dakota, Ascensus College Savings Recordkeeping Services, LLC, Ascensus Broker Dealer Services, Inc., and any other FINRA member are not eligible to participate in the Lemonade Locator Drawings ("Drawings", each a "Drawing") identified below.
- **2. How to Enter**: Eligible Individuals may enter a random Drawing online at www.bob95fm.com/lemonade/ by midnight on August 10, 2023. Limit per Drawing: One (1) entry per household. Each Eligible Individual who enters shall hereinafter be referred to as an "Entrant." No mechanically reproduced, illegible, incomplete, forged, or altered entries will be accepted. The Sponsor is not responsible for lost, late, corrupted, or misdirected entries, whether due to technical or computer malfunctions or otherwise.
- **3. Random Drawing/Odds**: Three (3) winners from the pool of Entrants will be selected on or about August 11, 2023, in a random drawing ("Drawing") from all eligible online entries received by co-sponsor Bob 95 FM by midnight August 10, 2023. The odds of winning a Prize from the Drawing depend upon the number of entries submitted by the Eligible Entrants and received by the Sponsor for inclusion in the Drawing. (Limit one (1) entry per household).
- **4. Prizes**: Subject to the requirements outlined in Section 5 below, Three (3) winners (each a "Winner") selected by the Sponsor will each receive Five Hundred and Twenty-Nine U.S. Dollars (\$529.00) in the form of a contribution to the Winner's account in College SAVE, a Section 529 college savings plan offered by the Bank of North Dakota (the "Prizes"). All remaining Entrants who submit their lemonade stand and hours will each receive Twenty-Five Dollars (\$25.00) in the form of a contribution to the winner's new or existing account in College SAVE. All potential winners are subject to eligibility verification by the Sponsor, whose decisions are final and binding in all matters related to the Drawings. An Entrant is not a Winner of any Prize unless and until the Entrant's eligibility has been verified and the Entrant has been notified that verification is complete. The Prizes are non-transferable. The Sponsor is responsible only for delivery of the Prize; not responsible for Prize utility or otherwise. The Drawings do not take into account a Winner's personal circumstances or other factors that may be important in making investment decisions. Investment returns are not guaranteed and the Winner could lose money by investing in College SAVE. In the event a Winner whose eligibility has been confirmed does not have an existing College SAVE account, the Winner will be required to complete the documentation necessary to open a College SAVE account, including an enrollment form with investment instructions in order to receive the Prize. (A College SAVE account is required to be opened in order to deposit the Prize, but the selected Winner is not required to deposit any additional monies into the account in order to receive the Prize.) - **6. Miscellaneous and Conditions of Participation**: The Drawings are void where prohibited or restricted by law, and are subject to all applicable federal, state, and local laws and regulations. Except where prohibited by law, all issues concerning the construction, validity and enforcement of these Official Drawing Rules, or the rights and obligations of the Entrant and Sponsor, shall be construed and governed by the laws of the state of North Dakota without regard to conflicts of law. All suits or claims brought in connection with the Drawings must be brought in a state or federal court in North Dakota. Taxes and fees, if any, are the sole responsibility of the Winner. By entering a Drawing, entrants fully and unconditionally agree to be bound by these Official Drawing Rules and the decisions of the Sponsor, which will be final and binding on all matters relating to the Drawing, and warrant that (s)he is eligible to participate in the Drawing. The Sponsor reserves the right to disqualify any Entrant if these Official Drawing Rules are not followed, change, alter, or amend these Official Drawing Rules or alter, modify, suspend, or terminate a Drawing, as necessary, in its sole discretion, to ensure the fair administration of the Drawings or to comply with applicable law. The Drawings are not a recommendation to invest in College SAVE.
- **7. Release**: Each Entrant agrees, except where prohibited by law, to release and discharge, hold harmless, and indemnify the Sponsor, its employees, agents and representatives, officers and directors and their immediate families, successors and assigns, and all others associated with the development and execution of the Drawings, from any and all tax liability that may be imposed or associated with receipt or use of the Prize, and from and against any and all claims, actions, proceedings, and liability for any damages, expenses, fees, injury, or losses sustained in connection with the receipt, ownership, use, or misuse of the Prize or while traveling to, preparing for, or participating in any Drawing-related activity.
- **8. Publicity**: Except where prohibited by law, by entering a Drawing or by winning, Entrants grant to the Sponsor the right to publicize the Entrant's name, photograph, image, likeness, voice, statements, and biographical information in all manner and

Limitations of Liability**: The Sponsor, its employees, agents and representatives, officers and directors and their immediate families, successors and assigns, and all others associated with the development and execution of a Drawing shall have no responsibility or liability for (i) any incorrect or inaccurate information, whether caused by Entrants, printing errors, or by any of the equipment or programming associated with or utilized in a Drawing; (ii) technical failures of any kind, including, but not limited to, malfunctions, interruptions, or disconnections in telephone lines or network hardware or software; (iii) unauthorized human intervention in any part of the entry process or a Drawing; (iv) technical or human error which may occur in the administration of a Drawing; or (v) failed, incomplete, garbled, jumbled, corrupted, or delayed computer transmissions which may limit an individual's ability to enter a Drawing, including any injury or damage to Entrant's or any other person's computer relating to or resulting from entering a Drawing or downloading any materials related to a Drawing.
