# Saint John Idol Rules and Regulations

### **General information**

Saint John Idol will be held on the Wave Stage on the Market Square boardwalk, Wednesday evenings beginning June 28<sup>th</sup>, 2019 starting at 8pm.

Contestants are not to use the Saint John Idol Logo or promote without authorization from Acadia Broadcasting and Market Square.

# **Eligibility**

You must be a permanent resident of Kings County, Saint John County or Charlotte County. You are ineligible if you already have either talent representation or a recording contract. Saint John Idol is open to contestants of all ages.

#### The Process

All applicants must perform on opening night, Wednesday June 28<sup>th</sup>, 2019. Each applicant will be expected to perform for maximum 60 seconds *A Cappella* in front of the judges. Order of performance will be random. Judges will assess performers and successful candidates will then be informed of dates and times to proceed through contest. There will be only ONE cut after the first week of *A Capella* performances. The audience, through online voting, along with judge scores will decide the winner of Saint John Idol. Votes are received and tallied by a non-partisan web master. There will be weekly challenges for which contestants will be judged on and assigned points based on success achieved during challenge. These points will be determined by judges and will be accumulated toward grand prize winner points.

Contestants chosen to move on past opening night will be permitted to bring their own instrument for their performance. Contestants will also can invite 1 guest *only* to accompany them should they not be able to play an instrument on their own. Event organizers must be informed 1 week in advance of any technical requirements.

## **Prizing**

Beginning week of July 3rd, contestants will compete in their first weekly challenge. Weekly challenge winner will be awarded \$250 cash and points toward grand prize winner. The grand prize winner will be awarded a \$5,000 cheque.

# **Disqualification**

We reserve the right to disqualify or exclude, in our sole and absolute discretion, any individual from any of the auditions for any reason. We also reserve the right to change the rules and procedures at any time. Being chosen to audition at any level in the process does NOT ensure that you will be selected to continue to the next stage.
