5. Six (6) nomination emails will be selected at random from all the qualifying emails and posted on the station websites. If any of the six selections are disqualified after the Heartland home inspection (see #2) an additional entry or entries will be selected for a pool of six finalists.
6. The public will vote for the nominated person or family they feel is most in need of replacing their current HVAC heating and cooling system. Individuals may vote once per contest.
