(Seguin) – Tyson Foods is not only “Feeding you like family,” it’s also supporting its family with educational resources.

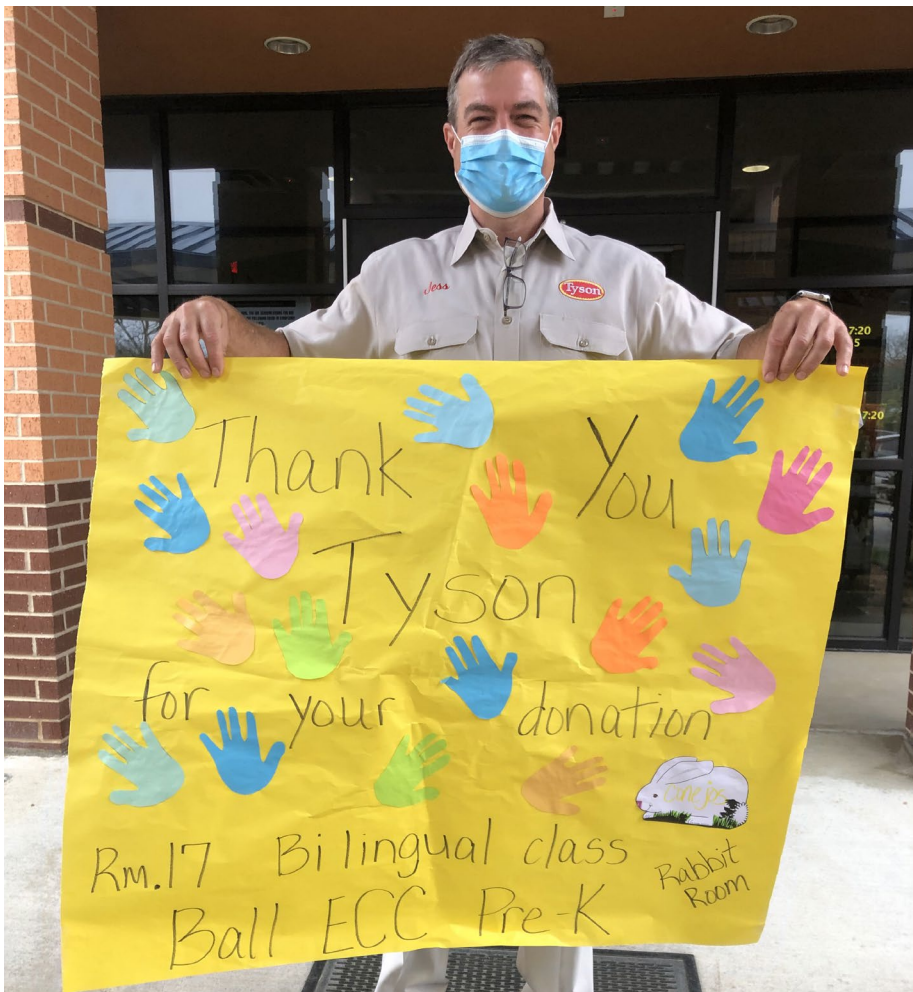

Seguin ISD's top administrator picks up nomination for TASB Superintendent of the Year award

(Seguin) – The leadership efforts of Seguin ISD Superintendent Dr. Matthew Gutierrez are not going unnoticed. The Seguin ISD Board of Trustees recently voted to nominate Dr. Gutierrez for consideration for this year's title of Texas Association of School Boards Superintendent of the Year.

School Board President Cinde Thomas-Jimenez says the nomination follows a challenging yet successful year for Dr. Gutierrez who has worked around the clock ensuring the safety and academic well being of all students.

Dr. Gutierrez says he appreciates the board for the recognition and believes his success is one to be shared by all families, teachers and community members.

"It's absolutely an honor but what an hour to be recognized by your board during a very challenging time for all of us, for the school district. We have all experienced hardships in some way and I'm just thankful that they have recognized my leadership through all of this, but I truly believe that my success this school year has to be attributed to our staff and to our parents and community. They have all given me so much grace this year and I think we are always surrounded by controversies that other school districts are experiencing right now during COVID since early on and even today and the Seguin community has truly come together because the community wants to ensure that students and staff are safe and so any and all major decisions – our community has asked questions, they've



been engaged but they've been supportive and I could not be more thankful for that," said Gutierrez.

Dr. Gutierrez now waits to see if he is honored to hold the title for the region. He says the nomination alone is an honor.

"In the past, I've seen superintendents being nominated by their boards or worked with superintendents who have been nominated and I always thought that would be so neat for me the day when I become a superintendent and so for it to be happening is certainly something that makes me proud and proud to be serving the Seguin ISD," said Gutierrez.

Following its vote last week, The Seguin ISD Board of Trustees authorized that a resolution in honor of Dr. Gutierrez be sent to TASB. The resolution as stated by the board nominates him for "his exemplary and visionary leadership toward improving student performances in our schools."

Dr. Gutierrez has served as superintendent of schools for the Seguin ISD since July 2017.

DRUGS PLUS money seized in Guadalupe County

(Schertz) – Two area men were arrested following a narcotics operation on the west end of Guadalupe County.

The Guadalupe County Narcotics Task Force conducted the operation on March 25 in the 17,000 block of IH-35 Frontage in Schertz. The operation resulted in the arrest of two 23-year-old males and the seizure of narcotics. The task force also seized 210.62 grams of methamphetamine, 10.82 grams of marijuana, U.S. Currency, and drug paraphernalia.

Taken into custody were Joshua Cantu of San Antonio and Nathan De Los Santos of New Braunfels. Both were arrested and booked into the Guadalupe County Adult Detention Center on charges of manufacture or delivery of a controlled substance in penalty group between four and 200 grams.

De Los Santos also had an active arrest warrant for a parole violation for an original offense of manufacture or delivery of a controlled substance in penalty group between four and 200 grams.

The Guadalupe County Narcotics Task Force is composed of narcotics investigators and detectives and criminal interdiction units from the Cibolo Police Department, Guadalupe County Sheriff's Office, and the Seguin Police Department.

“Donor.org is kind of like a GoFund for public education teachers nationwide and teachers can write to ask for any materials they want for their students. Tyson is matching donations, so I have an anonymous donor from Maryland that gave \$300. Tyson comes and matches this. Allstate has also matched some funds for us and so because of that funding you are able to get all of these materials free for your students and they ship it to your school. You can write grants under technology. You can write grants under literacy. You can write grants under STEM projects. They have guidelines that you have to follow and one of the things that we have to do is we have to show through photos the kids using the materials in the classroom or at home and so this is the beginning. We have to thank the major donor which was Tyson for this donation because this is over \$800,” said Molina.

Molina says the best part of the process might just have been the simplicity of applying for the funds.

“Tyson had already told us that they would fund projects in Seguin for teachers because we have a plant here. Because Tyson is doing a campaign for education this year, they will match funds for teachers up to \$1,000 so we had the opportunity to go ahead and write those grants and submit them and then they will go in there and rate them and they select, and they send you an email overnight and say ‘Guess what? Your project is getting funding. It’s on its way and we get it,’” said Molina.

Although kids were gifted with backpacks, it was perhaps Tyson’s Complex Manager Jess Chadick who walked away with the best gift of all that day. Not only was he given a handmade thank you sign and Easter basket, but he was also serenaded by an excited group of pre-k students.

“Mucho gracias. Mucho gracias...a Tyson.... We say thank you. We say thank you for our backpacks, for our backpacks. We say thank you. We say thank you...to Tyson....”

Chadick says his visit to Ball was definitely a highlight. He says going around presenting checks throughout area communities on behalf of Tyson Foods is always the best part of his job.

“We have an application process that is available for any groups or schools mainly in some of the public schooling type deals or food banks. We’ve done one of those lately and that application process is pretty self-explanatory. People can go online on the Tyson.com website and find the avenue to go in for the application. There is a choice that we make in those but schools, mostly anything that is located in the communities where we have facilities really has a good chance of getting grants through our company and to me, the more people that apply for it, the better. So, I encourage people to look at Tyson and look at what the application process is. Fill it out to their needs and apply for it because I’m here to tell you we do it all the time and it’s something that our company takes pride in,” said Chadick.

Mules hand Matadors fourth straight DISTRICT LOSS

(San Antonio) - Seguin finished up the first half of the District 26-5A baseball schedule with a 6-2 loss to Alamo Heights on Thursday at the Mule Yard in San Antonio.

The Matadors took a 1-0 lead in the top of the third inning when Alex Concepcion singled and came home on a base hit by Cory Mazzurana, but a momentum-turning play happened immediately after the run scored.

Tristan Moreno sprinted toward the plate behind Concepcion, and Alamo Heights catcher John Silva tagged Moreno out on a throw from centerfielder John York. After a hard collision between Moreno and Silva and some extracurricular pushing following the play, the home plate umpire removed Moreno from the game.

The domino effect from that decision took Moreno off the mound after he had retired the first six Mules in order over two scoreless innings. Tim Belicek moved from shortstop to pitcher, Micah Rodriguez from second base to shortstop, Concepcion from center field to second, and Marques Washington from the dugout to center field and the leadoff spot in the batting order.

Belicek worked around an error to keep Alamo Heights scoreless in the third, but the Mules used three hits and two Seguin errors to break through with five runs (three unearned) in the bottom of the fourth.

Rodriguez singled to lead off the fifth, Drew Burnett reached on an error, Mazzurana loaded the bases with an infield single, and Heston Osborne walked to drive in Rodriguez. Alamo Heights left fielder caught a fly ball off the bat of Belicek for the second out and threw out Burnett at the plate to end the inning.

The Mules tacked on an insurance run in the bottom of the sixth. The Matadors stranded five runners over the final three innings.

Osborne went 3-3 at the plate, while Mazzurana and Rodriguez each finished 2-3.

Belicek allowed six runs (two earned) on four hits with three strikeouts in four innings.

Seguin is 2-6 in district play at the mid-point of the 26-5A schedule, 6-14-1 overall. The Matadors head back to San Antonio on Tuesday for a 7 p.m. first pitch against Veterans Memorial.

ZUNKER

Dr. Vernon George Zunker, age 93 of San Antonio, formerly of Seguin, passed away on March 26, 2021. Vernon was born on September 18, 1927 in New Berlin, Texas to Nelda (Petry) and Louis Adolph Zunker. A graduate of Texas Lutheran University, Dr. Zunker received his EdD degree from the University of Houston, with postdoctoral training at the University of Texas medical

School at Galveston where he completed a residency in clinical psychology. Vernon will be remembered as having served as Dean of Men and Dean of Students at Texas Lutheran University and later had a joint appointment during most of his tenure at Southwest Texas State University (Texas State), where he was Director of the Counseling Center for 18 years and taught graduate courses in counseling psychology for 24 years prior to being named Professor Emeritus. At Texas State, he established a student learning resource center, a career development resource center, and was instrumental in the development of a testing center and the university's credit-by-examination program. A licensed psychologist, Dr. Zunker was also a consultant to the Texas Rehabilitation Commission for more than two decades.

He is the author of the college textbooks, *Career Counseling: A Holistic Approach* and *Using Assessment for Career Development* – both in multiple editions and widely used internationally. He also authored two editions of *A Dream Come True: Robert Hugman and San Antonio's Riverwalk*.

He considered his almost 3 years of sailing in the Merchant Marine as one of his greatest learning experiences. He often told his students that as a teenager on his own in a number of foreign countries, he learned to appreciate the significance of cultural differences.

Vernon was a life-long faithful Christian believing in God's promises of grace and forgiveness and was a member at Emanuel's Lutheran Church in Seguin, Texas and Christ Lutheran Church in San Antonio, vTexas. At the heart of this incredible man was his love for his wife Rosalie.

Vernon is preceded in death by his wife Rosalie Streng Zunker, his parents and brothers, Louis, Harry Lee, and Edward Zunker.

Survivors include his nephews, Dr. John Zunker and Tommy Zunker.

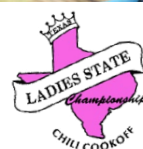
Private graveside services were held at San Geronimo Cemetery in Seguin with the Rev. Leslie Price and the Rev. Howard Stendahl officiating.

Dudley Duggan Baker III, 84, a native of Seguin, Texas, died peacefully in his sleep at home in Austin on Tuesday, July 14, 2020. He was a loving husband and father, dedicated parishioner, and a lifelong fan of his beloved Longhorns. He was a patron of the arts, enjoying both symphony and opera. He enjoyed good wine and cheese but was also a fan of Tex-Mex food and dark beer. Dudley was an outdoorsman and enjoyed visits to the Texas coast for fishing, crabbing, and birdwatching. He was a kind and

gentle spirit and he will be greatly missed.

Protective Benefits of mRNA COVID-19 Vaccines

(undated) -- A new CDC study provides strong evidence that mRNA COVID-19 vaccines are highly effective in preventing SARS-CoV-2 infections in real-world conditions among health care personnel, first responders, and other essential workers. These groups are more likely than the general population to be exposed to the virus because of their occupations.

The study looked at the effectiveness of Pfizer-BioNTech and Moderna mRNA vaccines in preventing SARS-CoV-2 infections among 3,950 study participants in six states over a 13-week period from December 14, 2020 to March 13, 2021.

Results showed that following the second dose of vaccine (the recommended number of doses), risk of infection was reduced by 90 percent two or more weeks after vaccination. Following a single dose of either vaccine, the participants' risk of infection with SARS-CoV-2 was reduced by 80 percent two or more weeks after vaccination.

It takes about two weeks following each dose of vaccine for the body to produce antibodies that protect against infection. As a result, people are considered "partially vaccinated" two weeks after their first dose of mRNA vaccine and "fully vaccinated" two weeks after their second dose. These new vaccine effectiveness findings are consistent with those from Phase 3

clinical trials conducted with the vaccines before they received Emergency Use Authorizations from the Food and Drug Administration. Those clinical trials evaluated vaccine efficacy against COVID-19 disease, while this study evaluated vaccine effectiveness against infection, including infections that did not result in symptoms.

"This study shows that our national vaccination efforts are working. The authorized mRNA COVID-19 vaccines provided early, substantial real-world protection against infection for our nation's health care personnel, first responders, and other frontline essential workers," said CDC Director Rochelle P. Walensky, MD, MPH. "These findings should offer hope to the millions of Americans receiving COVID-19 vaccines each day and to those who will have the opportunity to roll up their sleeves and get vaccinated in the weeks ahead. The authorized vaccines are the key tool that will help bring an end to this devastating pandemic."

One of this study's strengths is its design: participants self-collected nasal swabs each week for RT-PCR laboratory testing, regardless of whether they had developed symptoms of illness. Researchers were able to look for evidence of SARS-CoV-2 infection irrespective of symptoms. A small number (10.7 percent) of infections in this study were asymptomatic (i.e., did not result in symptoms). **Continued on next page...**

How mRNA COVID-19 Vaccines Work

Understanding the virus that causes COVID-19.

Coronaviruses, like the one that causes COVID-19, are named for the crown-like spikes on their surface, called **spike proteins**. These **spike proteins** are ideal targets for vaccines.

What is mRNA?

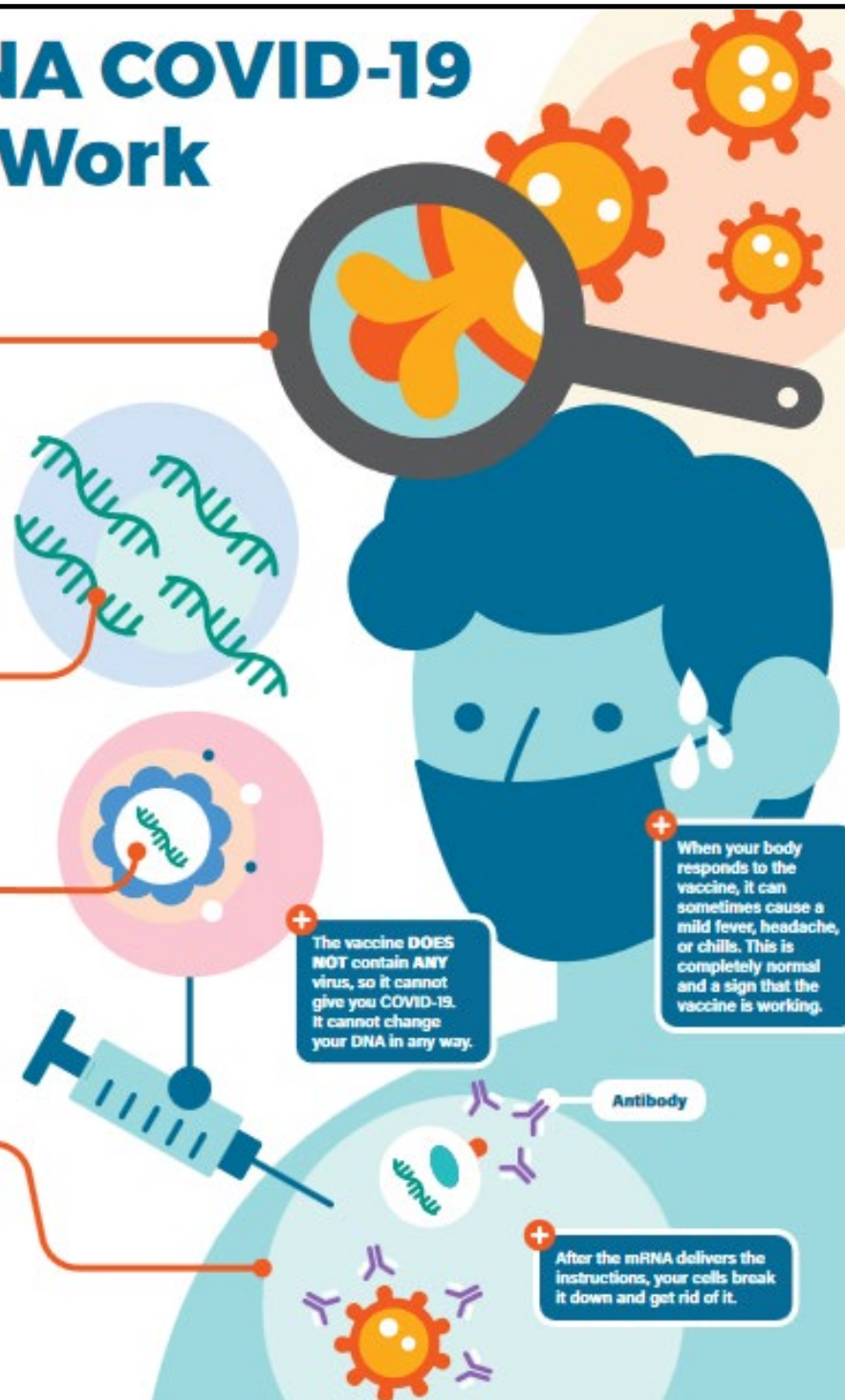
Messenger RNA, or mRNA, is genetic material that tells your body how to make proteins.

What is in the vaccine?

The vaccine is made of mRNA wrapped in a coating that makes delivery easy and keeps the body from damaging it.

How does the vaccine work?

The mRNA in the vaccine teaches your cells how to make copies of the **spike protein**. If you are exposed to the real virus later, your body will recognize it and know how to fight it off.



However, the majority of infections (58 percent) occurred among people whose infections were identified by testing before they developed symptoms or knew they were infected. The study demonstrates that these two mRNA vaccines can reduce the risk of all SARS-CoV-2 infections, not just symptomatic infections.

This is important because preventing both asymptomatic and pre-symptomatic infections among health care workers and other essential workers through vaccination can help prevent the spread of SARS-CoV-2 to those they care for or serve. Findings from this study complement earlier reports that these two mRNA COVID-19 vaccines can reduce both asymptomatic and symptomatic SARS-CoV-2 infections.

This study also provided positive news about partial (one-dose) vaccination. The one-dose VE estimate of this study (80 percent) is consistent with other recent VE studies following the first dose of Pfizer-BioNTech vaccine among health care providers. Studies conducted in the United Kingdom and Israel showed that one dose was about 70 percent and 60 percent effective, respectively, against SARS-CoV-2 infection. The current results provide reassurance that people start to develop protection from the vaccine two weeks after their first dose. The greatest protection was seen among those who had received both recommended doses of the vaccine.

This CDC study was conducted through the HEROES-RECOVER network, a network of prospective cohorts that share a common protocol and methods. This network is part of a vaccine effectiveness surveillance system made possible by federal pandemic flu preparedness funding.

This study is the first of many planned COVID-19 vaccine effectiveness studies CDC is conducting to evaluate the benefits of COVID-19 vaccines in various populations and across different outcomes, such as preventing infections, doctor's visits, hospitalizations, or deaths. Results from these studies assist the medical and public health experts on the Advisory Committee on Immunization Practices and CDC to make important vaccine policy decisions aimed at saving lives.
