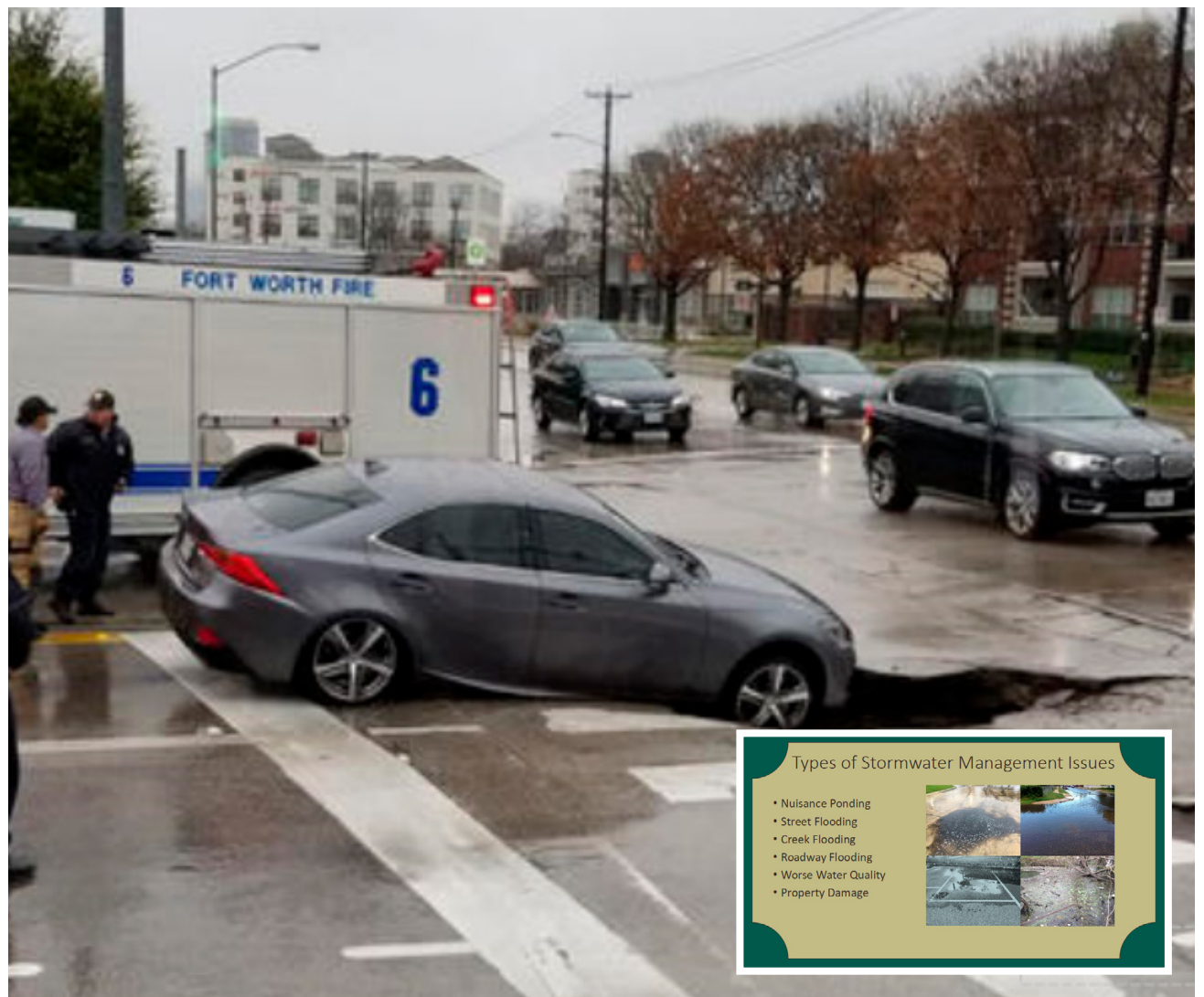
## City approves stormwater drainage fee *Fee provides funding for drainage projects, protects city streets*

(Seguin) -- Drainage issues are a serious problem in the city of Seguin. Not only are there ponding and flooding issues in many parts of the city, but the lack of an adequate drainage system is also damaging the city's streets. The city is now taking steps to improve its overall drainage system. The Seguin City Council recently approved the creation of a storm water drainage fee. The new fee will cost most residents \$3 per month, but it will allow the city begin further addressing some of its drainage woes.

Seguin City Manager Steve Parker says the fee is the most equitable way for the city to begin to seriously address drainage problems. He says those issues have also become a major problem for city streets. Parker says the streets are deteriorating because the drainage system can't properly handle the storm water runoff.

# Christmas trees being collected by city

(Seguin) -- The holiday season is officially over, and that means it's time to get rid of those fresh Christmas trees. The city of Seguin is offering residents a couple of ways to get rid of their natural Christmas trees.

Public Information Officer Jennifer Sourdellia says you will need to remove everything off the tree, but they've tried to make the disposal process easy.

"We will collect the Christmas trees on the resident's regular collection day, but we do ask that everyone take (off) the stand, lights, ornaments and any other decorations. We need all of that stuff removed from the tree, so that we can properly dispose of those trees. And also those trees need to be cut in half, before they are placed on the curb and collected," said Sourdellia.

If you don't want to chop the tree in half, you can simply have it picked up as part of the city's normal brush collection service. This might take a little bit longer, based on your brush pick up day, but it's yet another way to have your tree removed.

"They can place their tree on the curb, and it

will be collected as part of the regular city brush collection rotation. What we are asking people to do is to put their Christmas trees out at the curb on the Monday morning of their designated week to make sure that it's picked up. Again, all of the ornaments, lights, stands (or) any decorations on that tree -- we need to have all that removed before it's collected," said Sourdellia.

If you're not sure when the city has you scheduled for brush pickup, you can go online and find that information.

"People can go onto our website. We've got a place on our website where they can find their brush collection date and their zone, by visiting [seguintexas.gov](http://seguintexas.gov). There's a link on the public works page -- a brush link. So our residents can simply go there, locate their zone and that will tell them their collection date," said Sourdellia.

So again cut your fresh Christmas tree in half if you want it picked up as part of your regular garbage collection, or you can leave it whole and it will be picked up later this month as part of the city's regular brush collection efforts. If you need more information, you can contact the city's public works department.

"The city council has directed us to put a lot of money towards the refurbishment of our streets and the maintenance of our streets. The problem is without a adequate drainage system, unfortunately those streets will not last, because water just sits on that. The number one problem with roadways is when water does sit on your streets. It doesn't get to drain, and that asphalt doesn't last as near as long (as it should). So we

are kind of throwing good money after bad. This talented team of individuals that we have went out and found a solution. (They found) a sustainable solution that we feel like that we can actually have a dedicated funding source in the amount of a fee," said Parker.

The city has hosted a number of public meetings to discuss the creation of the fee. It establishes a dedicated funding mechanism to address flooding and other drainage issues. Parker says they initially

proposed a higher monthly fee, but later realized that the \$3 monthly rate would allow the city to begin to address some of these issues.

"We started out with a \$5 fee. But after talking to the audit committee, we reduced that \$3 per residential unit a month. So it's \$36 per year for every residential customer. Commercial customer (fees) will be based on the amount of impervious cover that they have on their property overall."

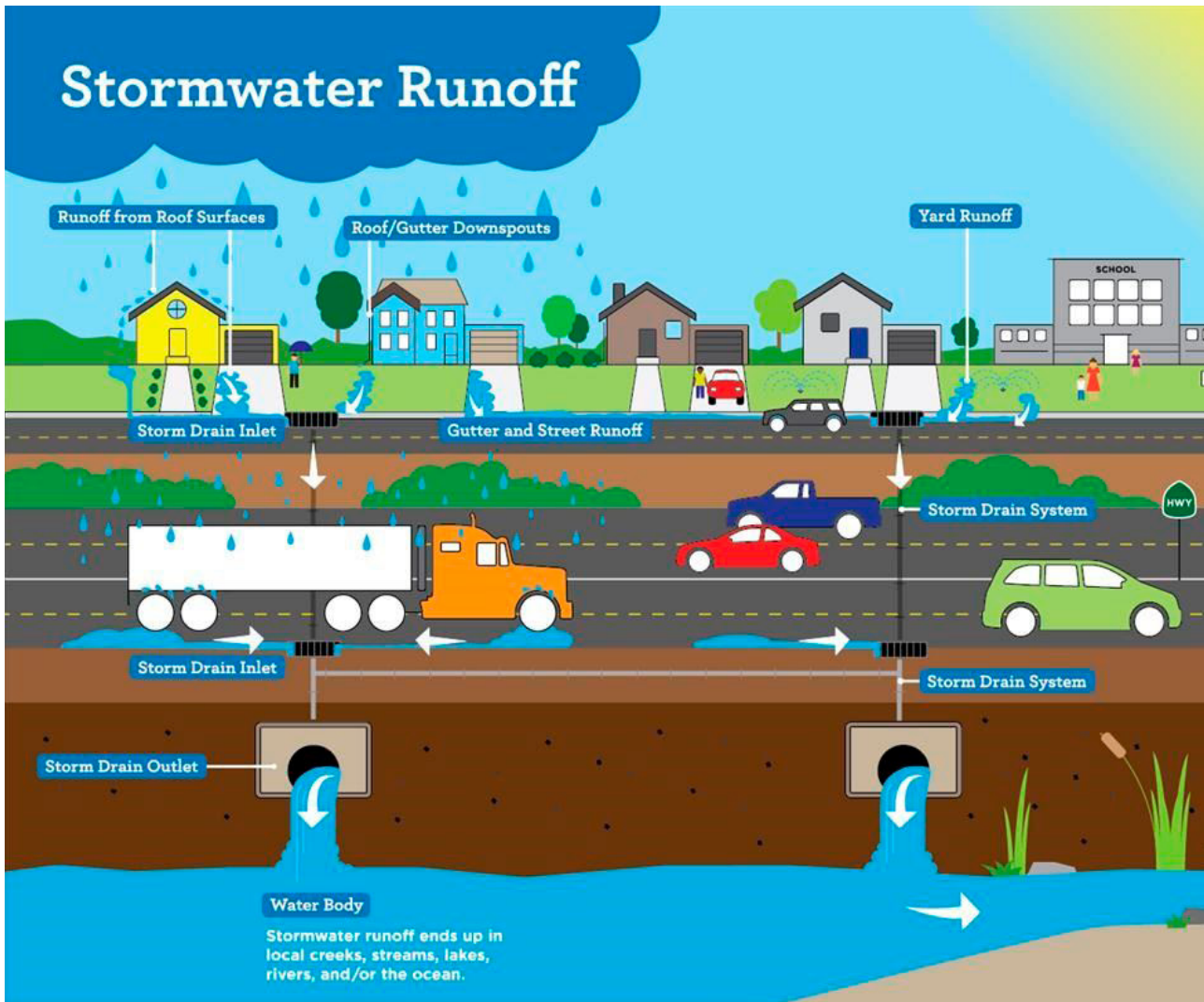

“So if it’s 10,000 square feet of impervious cover -- we’ll divide that by 2,500 square feet, which is the average residential unit (size). That makes a basis of four (and) we’ll multiply that times \$3 and (in this case) that would be \$12 a unit. That money will then be (used), this first go round, to come up with a sustainable capital improvement plan,” said Parker.

Parker says they want to be able to come up with a responsible plan for how this money will be used. He says once the fee starts being collected, it will allow them to begin to do some of the necessary planning for drainage upgrades.

“We know a lot of the projects and a lot of the areas where we need help. We need some money to actually go out and do some preliminary designs, so that we can actually come up with a cost benefit analysis related to how we spend that money that we do generate from this fund. Do we spend \$5,000 in this area and help 100 homes get out of a flood area, or do we (spend more and help) a thousand homes get out of a flood area. This will help us do that. And then we can also work for the council to say -- can we do more if we use more of the funds, (and) if we want to reduce the funds -- we could always look at those types of issues. Unfortunately, we need a lot of money to maintain this system (and) to mow the drainage ways. If you’ve been around any of

the recent floods over the last several months, you’ve seen the impact to areas where water just stands,” said Parker.

Critics have suggested that the city look at increasing its property tax rate or using more of the city’s sales tax revenue to pay for some of these drainage projects. But Parker says that it would take a large tax increase to generate the kind of revenue that would be created by the drainage fee. He says this is a much more equitable, and he believes a better way to fund these projects.

“Anytime you charge anyone an additional fee, (people may not be happy about it),” said Parker.

“It is something, in our professional opinion, that we think is needed if we ever want to change the trajectory of our roadway system here in Seguin. We are just throwing good money after bad, if we are just paving those roads and they are only lasting for eight years, when they should be lasting 20 years.”

The council approved the fee, on first reading, during its last meeting in December. A second and final reading is expected to be approved during the council’s meeting slated for 5:30 p.m. Tuesday at Seguin City Council. The public will be given an opportunity to address the issue prior to that vote.

If the final reading is approved, the fee would start being collected in January of 2023. The city wanted to give residents and businesses a full-year to be prepared for the additional fee that would be collected at that time.

# Seguin girls struggle after halftime, fall at home to Boerne-Champion

(Seguin) - The Seguin girls basketball team jumped out to a 7-0 lead in the first quarter and kept Friday's district game against Boerne-Champion close for a half, but the Chargers used a 16-4 run in the third quarter to pull away and hand the Matadors a 50-26 loss at the SHS Student Activity Center.

Junior guard Reese Brittain scored the first seven points of the game, but Champion responded with its own 7-0 run, and the game was tied at the end of the first period.

The Chargers won the second quarter 13-9 to take a 20-16 lead into halftime. Seguin went cold offensively in the third period while Champion reeled off 11 straight points as part of a 16-4 run to put the Mats in a 36-20 hole.

Seguin came no closer than 14 points in the fourth quarter, and the Chargers scored the game's final eight points to push the margin to 24.

"We just quit shooting altogether," Seguin head coach Angie Brittain said. "We just wanted to play slow, and not have ball movement

to get them out of their system. We didn't even shoot, so that's hard to win a game when you're not even shooting. You can't score points if you don't shoot, and then go get the rebounds if you miss. We kind of just froze the second half."

Reese Brittain scored 16 points, but no other Matador reached double figures. Renee Mata added five points, Tresalyn Roberts four, and Ashlie Aguilar one.

Champion's size made it difficult for Seguin to generate quality quality shots, and the Chargers drained nine threes on the offensive end.

The loss drops Seguin to 3-3 in District 26-5A, 14-12 overall. The Matadors look to bounce back Tuesday afternoon in a 2 p.m. road game at Dripping Springs.

"We're just going to keep brushing up our offense," Brittain said. "I've got some ideas, plans, and then go take it out on Drip. That's a big game for us Tuesday, so we've got to figure it out."



## Baum, Chargers too much for Mats in district loss

(Boerne) - Boerne Champion's Braden Baum poured in a school-record 44 points to help the Chargers hand Seguin an 84-51 road loss Friday afternoon in District 26-5A.

The setback drops Seguin to 0-4 in district play, 7-14 overall.

Kevon Williams led the Matadors with 11 points. Jakyari Matthews and John Jones added nine points apiece, John Jackson eight, Jeffrey Rodriguez seven, J'Dohn Cannon-High four, and Devin Matthews three.

Champion led 23-17 at the end of the first quarter, 48-29 at halftime, and 74-45 by the end of the third period.

The Matadors try again for their first district win Tuesday night when they host Dripping Springs at 6:45 p.m.

## Navarro girls' winning streak SNAPPED by 6A Unicorns

(New Braunfels) - The Navarro girls' basketball team's 18-game winning streak ended Thursday afternoon with a 56-47 road loss to 6A New Braunfels.

The Unicorns only led by a point, 27-26, at halftime, but they outscored the Panthers 29-21 in the second half to pull away for the nine-point win.

Navarro's Tatum Harborth led all scorers with 17 points. Laylin Sturm also reached double

figures with 12.

Berklee Andrews contributed seven points, Sienna Kramer six, Taylor Helms and Ryanne Hepp two each, and Tegan Harborth one.

Meredith Sherrard netted 14 points to lead New Braunfels, and Chloe Kossaeth chipped in with 11.

Navarro (22-4) returns to court Monday with a home game against Hondo at 11:30 a.m.

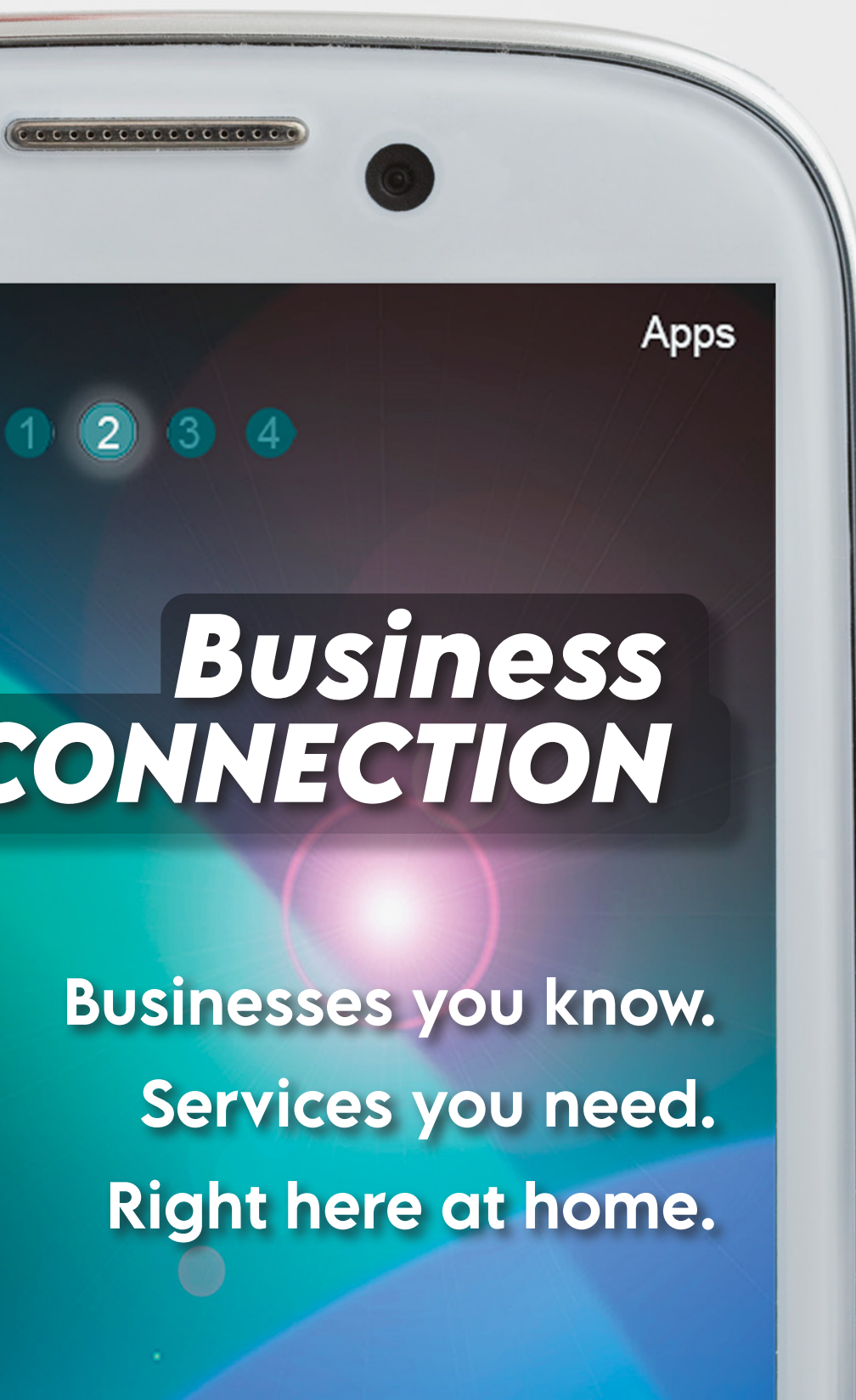

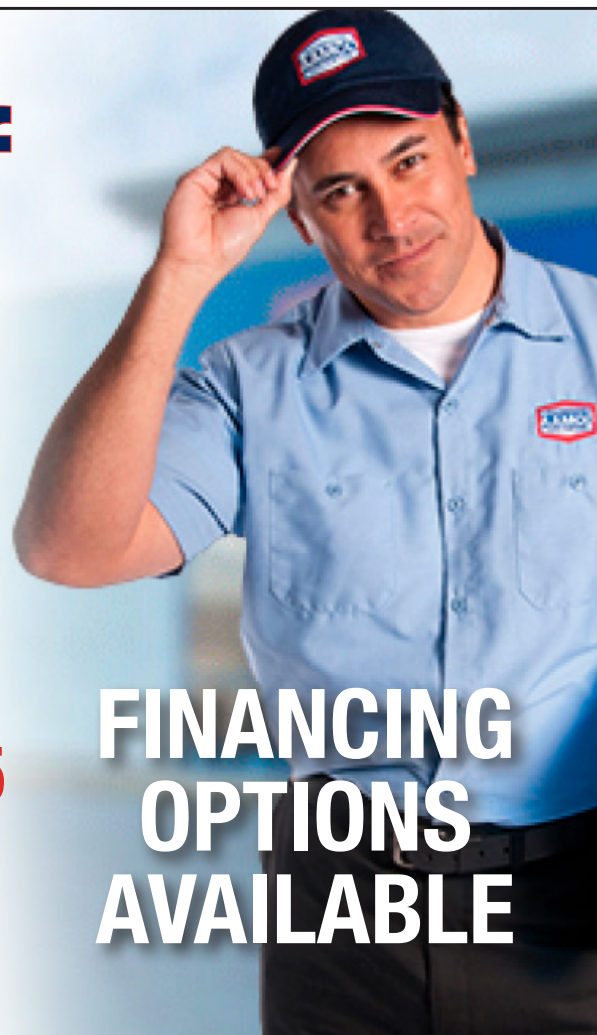

## Nation Sets Daily Record Of New COVID Cases

(Atlanta, GA) -- The COVID crisis is setting another grim record as millions celebrate the New Year. The CDC reports the nation hit a whopping 441,278 cases last Tuesday. That's the most ever in 24 hours since the pandemic began. This puts the weekly average at more than 240,000 infections a day. It's mainly due to the raging omicron variant.

## Report: Pediatric COVID Cases On The Rise

(Washington, DC) -- COVID cases among children are at their highest level in months. A new report from the American Academy of Pediatrics says nearly 200,000 U.S. children tested positive for COVID-19 at the end of December, which was up by about 50-percent since the beginning of the month. Over 2,000 children are currently in the hospital with the coronavirus. The report says daily pediatric COVID-related hospital admissions have more than doubled in the last month, and less than a third of eligible children in the U.S. have been fully vaccinated.

## WHO Says New COVID-19 Strains May Be Vaccine Resistant

(Switzerland) -- The World Health Organization is warning new COVID-19 variants that pop up could be resistant to current vaccines. The Director-General said it's possible new strains could require adaptations to vaccines. That which could mean a new supply shortage. He stressed the importance for nations to build local manufacturing supplies in anticipation of the virus evolving.

## COVID Rapid Test Possibly Less Sensitive In Finding Omicron

(Atlanta, GA) -- Early research shows some rapid antigen tests are possibly less sensitive at finding the omicron [ ahm-ih-cron ] variant of the coronavirus. CDC Director Dr. Rochelle Walensky addressed the research this morning on the Today show. Researchers with the NIH, along with the FDA, used samples from patients confirmed to have the omicron variant to study the effectiveness of antigen tests. Preliminary findings show antigen tests find the variant, but at a "reduced sensitivity," meaning they could miss an infection.

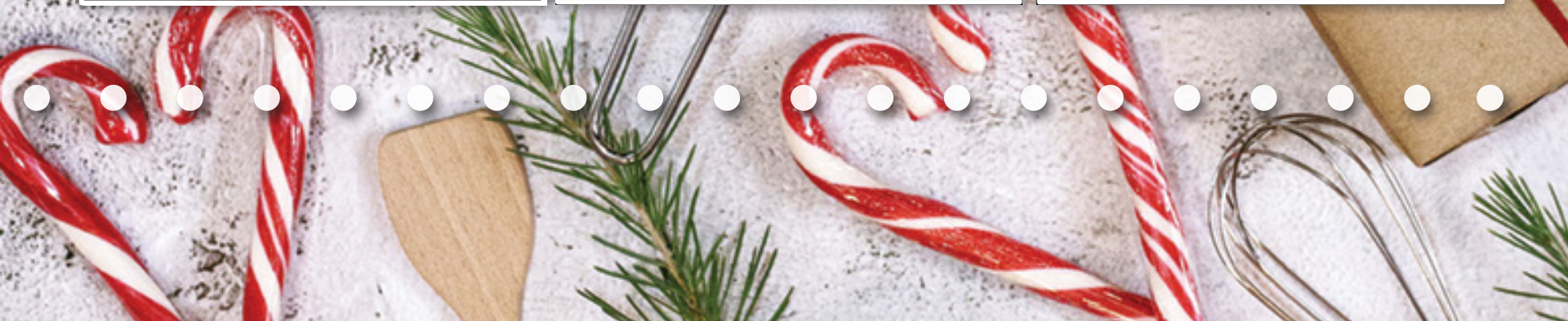
