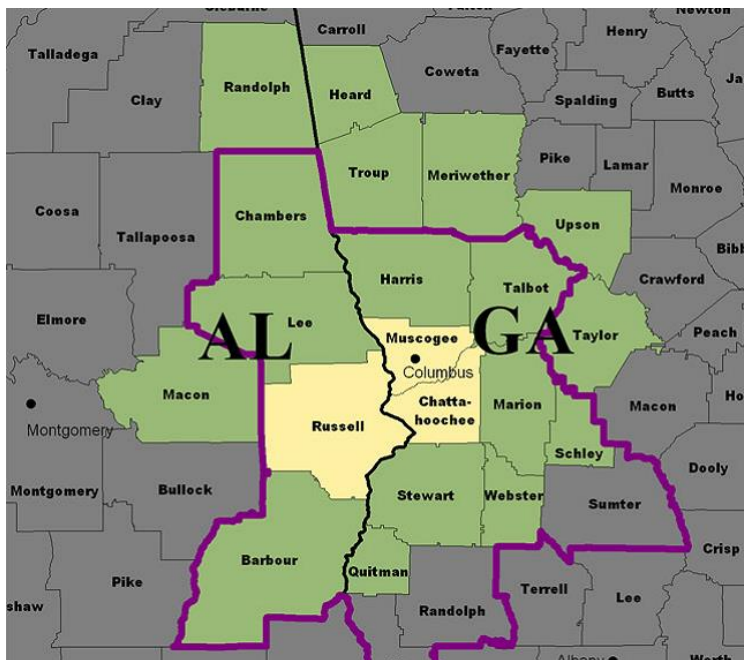




IMPORTANT CONTEST RULES

1. **CONTEST.** The Sponsor of the FALL 2023 SHIPROCKED CRUISE GIVEAWAY CONTEST (the "Contest") will give away one Ocean-View Cabin for two-guests on the "2024 Shiprocked Cruise" produced by ASK4 Entertainment with a Retail Price of \$3,853. (the "Grand Prize") and additional secondary prizes with various estimated values according to the terms and conditions of these rules. The Contest will run from August 28, 2023 to November 11, 2023. Radio broadcast stations WCKN-HD2 and WRCG are owned by PMB Broadcasting, LLC and are collectively referred to in these rules as the "Stations".
2. **SPONSOR.** The Contest is sponsored by PMB Broadcasting, LLC (the "Sponsor").
3. **ELIGIBILITY.** Except as set forth below, all individuals that are as of September 11, 2023, residents of the Columbus, Georgia Total Survey Area as defined by The Nielsen Company, and are over the age of 21 are eligible to participate in the Contest. Only one person may qualify per household. The Sponsor, and its respective affiliates, subsidiaries, agencies and divisions, participating promotional partners, and each of their respective employees and immediate family members are ineligible to participate in the Contest. The Contest is void where prohibited by law. Each individual that participates in the Contest agrees to be subject to and abide by these rules. Any deviation from these rules on the part of any participant will render that contestant ineligible. All decisions of the Sponsor are final.
4. **YOU MUST BE PRESENT AT THE DRAWING TO WIN**, being held at Saturday, December 2, 2023 at Rally Point Harley-Davidson, 3230 Williams Rd, Columbus, GA 31909. Based on the number available, Secondary Prizes will be drawn approximately every fifteen minutes beginning at 10:00 AM. The Grand Prize will be drawn at approximately 1:00 PM.
5. **NO PURCHASE IS NECESSARY TO ENTER OR WIN; VOID WHERE PROHIBITED BY LAW.**
6. **HOW TO ENTER.** Only eligible individuals that qualify for a chance to win will have a chance to participate in the Grand Prize Drawing and win. To qualify for a chance to win, an eligible individual must complete an online registration form provided by the Sponsor at a designated registration location and submit such completed registration, which may include Sponsor's website. Complete home address and date of birth must be provided in order for the registration form to be considered complete. Designated registration locations will become available between Monday, September 11, 2023 and Thursday, November 22, 2023 in and around the Columbus, Georgia area. The specific location of each designated registration location will be broadcast, from time to time, on one or more of the Stations and posted on the Stations' websites.

The chance of winning depends on the total number of completed entries received from eligible individuals.

Qualifiers may win an On-Air Qualifying Prize via random drawing of those entered into the contest at the time the on-air drawing is held and is subject to availability as described below in Section 7.

A list of all Qualified Individuals shall be posted on the Stations websites, the list will be updated once per week beginning September 18 up to the Grand Prize drawing on Saturday, December 2, 2023. Qualifiers must verify their name is listed on the Stations websites, a final list will be posted by the close of business on Tuesday, November 28, 2023. This shall be the final list of Qualifiers placed into the drawing receptacle for winning the Grand Prize and secondary prizes as described in Section 7 below. In the event a Qualified Individual is omitted from the posted list they should contact the Stations no later than 5:00 PM on Thursday, November 30, 2023 to verify their status as a Qualified Individual.

On Saturday, December 2, 2023, on or about 10:00 am, on the premises of Rally Point Harley-Davidson, 3230 Williams Rd, Columbus, GA 31909, the Grand Prize Drawing Event will be held. The Sponsor will place the names of the Qualified Individuals into a receptacle and begin to randomly draw a certain number of names depending on the number of secondary prizes obtained as described in Section 7 below. The last name drawn will be the winner of the Grand Prize – the Grand Prize drawing will occur at approximately 1:00 PM, winners of the secondary prizes will not be returned to the drawing receptacle after their name is drawn. In the event a Qualified Individual is drawn and not present, the Sponsor will continue to draw names until a Qualified Individual is present. Those names drawn during the secondary prize portion that are not present will be returned to the drawing receptacle for the Grand Prize drawing. **QUALIFIED INDIVIDUALS MUST BE PRESENT TO WIN.**

On-Air Qualifying Prizes may be awarded to those Qualified Individuals selected by the method described in section 6 subject to availability. The winners may be identified on the Stations after the winners have been awarded their prize.
10. **GENERAL CONDITIONS.** Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest, to be acting in violation of these rules, or to be acting in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person, or for any other reason deemed reasonable by Sponsor. If after the Contest has begun changes or updates in these rules are deemed necessary by Sponsor, all changes will be announced on the Stations. Sponsor reserves the right to change these rules at any time as it determines necessary in its sole discretion. Sponsor reserves the right to terminate the Contest if fraud, misconduct or technical failures destroy the integrity of the Contest, or for any other reason deemed reasonable by Sponsor.
11. **LIMITATIONS OF LIABILITY.** All participants agree to release and hold harmless Sponsor and all of its respective affiliated companies and all of their respective directors, officers, employees, agents, legal counsel, and/or participating promotional partners from all losses, damages, penalties, claims, actions, suits, costs, and expenses of any kind whatsoever and any property damage, personal injury, or death to any participant or third person caused by or arising out of or in connection with participation in the Contest or with the use of any prize awarded.
