HOW TO ENTER – ADDENDUM A

KOYY Y94 hosts will call names of listeners who have registered on the CRACK THE CODE page at www.Y94.com weekdays at approx. 7:10am, approx. 9:10am, approx. and approx. 11:10amm.

*Note: Due to the nature of our programs that are heard online over the internet, contests heard over the station's internet stream, are slightly delayed from the time the contests heard on the broadcast or the "Y94 app" and will be running behind the broadcast signal. Thus, all the contests heard are delayed. This delay can last for 30 seconds up to several minutes. This means when Y94 announces a winning name in this contest, listeners listening to the online stream may be at a disadvantage in participating over those listening to the broadcast on a tradition FM radio. For this contest, Y94 will begin counting the 15 minutes when the name is called over the tradition on air broadcast.

ADDENDUM B - METHOD OF SELECTION OF WINNER
