Eligibility:

Purchasers must not include the name of anyone under the age of 18 on the ticket due to the requirements of the Public Trustee Act.

Tickets may only be purchased or sold in Alberta.

Contest guidelines prohibit the following people from purchasing tickets in the lottery: Members of the Covenant Foundation's Board of Directors; employees of the Covenant Foundation, staff of Stride Management Corp, staff of Calder Bateman Communications Ltd. & Zero Gravity Marketing Inc.; & their immediate family members.

The Split 50 & Cash Calendar Lotteries are separate lotteries. Ticket Purchasers are not required to purchase a ticket in the Split 50 & Cash Calendar Lotteries to be eligible to purchase tickets in the DreamLife Lottery. However; ticket purchasers who only purchase DreamLife Lottery tickets & not the Split 50 & Cash Calendar Lottery tickets will only be eligible for the DreamLife Lottery draw being held on November 15, 2019.

Draw Dates and Order:

The Loyalty Draw, for both the \$10,000 Cash Prize & the Choice of 2 Lexus, will be the first draw held. It will take place on Wednesday, August 14, 2019.
