

The Q!s Win The Fuel RULES AND REGULATIONS

Thursday, August 30th - Friday, October 19th

- 1. **The Q!'s Win The Fuel** contest, hereinafter known as "the contest" is open to all British Columbia residents 18 years of age or older.
- Active and retired employees and their immediate families (including but not limited to 'significant others,' siblings, parents, children and any persons belonging to the household of the above persons) of The Jim Pattison Broadcast Group Ltd., 100.3 The Q!, Peninsula Co-Op, their affiliates, any participating sponsors, their affiliated corporations, agencies or agents are not eligible to enter/win the contest.
- 3. The contest is subject to all applicable federal, provincial and municipal laws and regulations.
- 4. To qualify to win the contest: Listen to The Q! each day from *Tuesday, September 4th Thursday, October 18th 2018* between 6:00am and Midnight. - 5. The opportunity to qualify to win <u>on-air</u> begins at **6:00AM on Tuesday**, **September 4**th and closes no later than **6:00pm on Thursday**, **October 18**th, **2018**.
- 6. Additional qualifier entries will be available through an instore draw opportunity at participating Peninsula Co-op locations from Thursday, August 30th Wednesday, October 17th. In-store semi-finalists will be drawn no later than Wednesday, October 17th at 6PM and announced no later than Thursday, October 18th on The Q! Minimum # of in-store winners 5 (five)
- 7. Odds of winning the contest depend on the number of qualified contestants. **Approx 250:1** for qualified contestants.
- 8. Qualified contestant spaces are limited to <u>one per person</u> Multiple entries by the same person will be void.
- 9. All qualifiers are required to attend the Grand Finale event in order to win. If they are not able to attend, they may send a proxy in their place or make suitable arrangements to be represented at the Grand Prize draw.
