

The Q!'s Game of Gnomes CONTEST RULES & REGULATIONS

- 1. The Q!'s Game of Gnomes contest, hereinafter known as "the contest," is open only to all British Columbia residents and homeowners 18 years of age or older.
- 2. Must submit a photo of their yard and the photo must include a gnome (can be photoshop) Downloadable "gnome" to print will be linked to the contest page.
 - (B) Listen to **The Q! Morning Show** each weekday from **Monday, April 29**th **Friday, May 10**th to find out if you are selected as one of the 10 (ten) finalists.
 - (C) **On Monday, May 13**th The Grand Prize Winner will be announced and will receive the Grand Prize of a Backyard Makeover valued at approximately \$15,000. Prize is to be accepted as awarded (see Rule #9 for prize details)
