



Q104's (CFRQ) "Naughty List" - Rules and Regulations

1. CONTEST PERIOD: Every day **November 19th - December 17th, 2018**
2. ELIGIBILITY: The "Contest" is open to all residents of Nova Scotia, who are 19 years of age or older with a valid ID, excluding employees of Q104, Stingray Radio Inc.
