



1. Dates/Terms/Eligibility. CIHT-FM (The New HOT 89.9) – Newcap Radio Inc. (the "Station") has set an expiry date of October 26th, 2018 for **The \$10,000 HOT Hit** (the "Contest"), however it reserves the right to terminate or extend the contest at any time. Any material changes will be broadcast on the Station and posted on its official website (www.HOT899.com), within the Contest section. The Contest is open to legal Canadian Residents and students 18 years of age or older, residing in the province of Ontario. There is no purchase necessary to participate or to win. Employees or agents of the Station, all other Newcap Radio stations in Canada, or any entity associated with the Contest, as well as members of the same household of any such employee or agent may not participate.

2. Prizes. There are multiple Grand Prizes to be won. The value of each Grand Prize is \$10,000 CAD. The odds of winning the Grand Prize will depend on the number of listeners who participate, and attempt to call in to win.
